STATEMENT OF COOPERATION

It is my understanding that the policy for the school is to make no refunds on registration, book and activity fees. I give Lifeline Baptist Christian Academy (also here called LBCA or "the school") permission for my child to take part in all school activities and school sponsored trips away from the school premises. I also believe that discipline is necessary for the welfare of each student, as well as for the entire school. I give permission for my child's teacher and/ or other agent of the school to make and enforce classroom regulations in a manner consistent with Christian principles and discipline as set forth in the Scriptures, excluding corporal punishment. To the extent not covered by insurance, I further agree to hold the school and its agents harmless from claims related to injury or alleged injury to my child, including attorney fees and other legal defense cost, except to the extent that such injury or alleged injury or alleged injury is caused by the negligence or willful misconduct of the school or its agent(s).

I give permission for the school to release any of my child's records (inc. academic, health, behavior and specialized testing) to schools and personnel who are considering my child for admission to their programme/school. As LBCA is a Christian ministry organisation, I, my spouse, and my children agree never to make demands, threaten to sue or actually litigate any matter whatsoever relating to or resulting from my child(ren) being (a) student(s) at LBCA. I, my spouse, and my children understand that making demands, threatening to sue or litigating a matter against Lifeline Baptist Christian Academy clearly violates Biblical teaching and practice and shall constitute sufficient grounds for immediate withdrawal of all my children from enrollment at LBCA. I understand that retaining or instructing an attorney to contact the ministry with regard to a potential claim or dispute will be interpreted as a threat to sue. Accordingly, the parties agree to resolve all potential claims, disputes, or causes of action through binding arbitration using the following outlined procedures:

a. I agree to follow the Biblical pattern of Matthew 18:15-17 and Galatians 6:1 and always give a good report. All differences are to be resolved by utilizing Biblical principles. Appropriate confidentiality will be observed in regard to pupil, parent, and school matters.

b. I agree that the Biblical method given here shall be the sole remedy for any and all controversies or claims arising out of my relationship with LBCA and expressly waive the right to file a lawsuit against LBCA in any civil court for such disputes, except to enforce a legally binding arbitration decision. c. I, my spouse, and my children, agree to abide by the procedural outlines in Matthew 18:15-1 7 and Galatians 6:1. This Statement of Cooperation will be in effect for as long as my child(ren) attend Lifeline Baptist Christian Academy, whether it be in kindergarten Grades 1-6, summer school or any school related activity. Should my marital status change, it is my responsibility to have an updated Statement of Cooperation signed and delivered to Lifeline Baptist Christian Academy. This agreement supersedes all prior agreements, oral or written, between the parties and is extended as a complete and exclusive statement of the agreement of the parties. Neither this agreement nor its execution have been induced by any representations, stipulations, agreements or understandings of any kind than those expressed herein. If any provision of this agreement is found to be void or voidable, it shall not affect the validity of any other provision. Both parties shall remain bound by all other provisions.
